# Certificate Course—Fundamentals of Neurotrauma Care for Nurses

May 9 – September 12, 2024



#### **Course Description**

This online certificate course program will combine lectures, tutorials, case studies, and skills videos to increase participants' basic understanding of evidence-based practice in neurotrauma. The self-paced video lectures will be available in a repository for remote access during the 18-week program duration. Participants can interact with other participants and faculty through a Forum. This tool allows participants to ask questions or post comments regarding a lecture in a module. Discussions will be available to all attendees in a repository form.

Recommended reading material is provided in advance to enhance the interactive learning experience.

#### Course program

The program is organized into twelve modules, sixty-four lectures, and ten skills videos. Each will be evaluated with a multiple-choice test, with an overall minimum required score of 70%. At the end of the twelve modules, participants will need to complete a final exam divided into two parts evaluating the whole program's content, which will be performed online.

It's important to note that the minimum required score for certification is 7.0/10 (70%). This score is calculated based on the sum of the module exams (60%) and the final exam (40%).

#### Target audience

This Global Neuro course was developed for nurses and is dedicated to the integral management of neurotrauma and complex and interdisciplinary patient care.

#### Learning Outcomes

By completing this course, participants will be better able to:

- Describe neurotrauma epidemiology worldwide and how different types of injuries can affect patients in different age groups.
- Develop an improved knowledge of anatomy and physiology and pathophysiology following injury of the brain and spine.
- Discuss the evidence base that supports nursing care for patients with External Ventricular Drains.
- Develop appropriate assessment and management skills for neurotrauma patients within different resource availability, utilizing protocols, guidelines, consensus, and evidence-based interventions in delivering patient care and improving outcomes.
- Develop the appropriate nursing skills to apply to the prehospital, emergency care, surgical, critical care, post-acute and rehabilitative care of neurotrauma patients.
- Demonstrate an understanding of care required in complex cases and in neurotrauma care related complications.
